The Ministry of Justice of Bosnia and Herzegovina, resolving on the basis of the Request of „Association of Composers - Music Authors“, with headquarters in Sarajevo, street Obala Kulina bana 22/II, in the matter of entry of changes in the Register of Associations, on the basis of Article 43 paragraph 2 of the Law on Associations and Foundations of Bosnia and Herzegovina („Official Gazette of BiH“, no. 32/01, 42/03, 63/08, 76/11 and 94/16) and Article 4 paragraph 1 of the Rulebook on Manner of Keeping the Register of Associations and Foundations in Bosnia and Herzegovina („Official Gazette of BiH“, no. 44/10 and 14/12), adopted

R E S O L U T I O N

1. In the Register of Associations of the Ministry of Justice of Bosnia and Herzegovina are registered changes with regard to „Association of Composers - Music Authors“, with headquarters in Sarajevo, street Obala Kulina bana number 22/II, registered on 12 September 2002 under the registration number: RU - 28/02 in the Book I of the Register, as follows:

1.1. Changes of the Statute of the Association, number: 01/16 dated 15 February 2016.

1.2. The address of the headquarters of the Association is changing, so instead of: „Sarajevo, Obala Kulina bana Street number 22/II“, is entered:

Sarajevo, Trg solidarnosti number 2a.

1.3. The adress of the Banja Luka Branch of the Association is changing, so instead of: „Banja Luka, Kralja Petra I Karađorđevića Street number 85“, is entered:

Banja Luka, Veselina Masleše Street number 1.

2. This Decision will be published in the „Official Gazette of BiH“, at the expense of the Applicant and on internet page of the Ministry.

R e a s o n i n g

“Association of Composers - Music authors“, with headquarters in Sarajevo, street Obala Kulina bana number 22/II is entered in the Register of Associations before the Ministry of Justice of Bosnia and Herzegovina under the registration number: RU – 28/02, the Book I of the Register on 12 September 2002.

On 20 April 2017, the Association submitted the Request for registration of changes in the Register of Associations before this Ministry.

Along with the Request for registration of changes in the Registry of Associations was submitted the following documentation: the Minutes from the General Assembly of „Association of Composers - Music authors“ dated 5 April 2017, with the list of members of the Association that were present; the Decision on Amendments of the Statute of the

Association, number: O-14/17 dated 5 April 2017 in two copies and proof of payment of administrative fee.

After reviewing the submitted documentation, it was found that the conditions prescribed by the Law on Associations and Foundations of Bosnia and Herzegovina and the Rulebook on Manner of Keeping the Register of Associations and Foundations in Bosnia and Herzegovina and Foreign and International Associations and Foundations and Other Non-profit Organizations, for registration of changes with the Register of Associations for „Association of Composers – Music Authors“ are met and thus it was resolved as cited above.

Administrative fee in the amount of BAM 200,00 was charged on the basis of this Resolution for registration of changes in the Register of Associations in accordance with Article 33 paragraph 2, point b) of the above mentioned Rulebook.

Notice on legal remedies:

An appeal to this Resolution is not permitted, however against it may be initiated administrative dispute by submitting a lawsuit before the Court of Bosnia and Herzegovina. The deadline for submitting a lawsuit is 60 days from the day of receipt of this Resolution.
