# ANNEX OF THE COLLECTIVE AGREEMENT ON REGULATING COPYRIGHT FOR BROADCASTING MUSICAL COMPOSITIONS

## Article 1

The following changes are made to Article 10 Paragraph (1), Paragraph (2) and Paragraph (5) of the Collective Agreement on broadcasting musical compositions, published in the "Official Gazette BiH" no. 80/12 on 9/10/2012

- 1) Through this Agreement the Collective organisation undertakes the responsibility to guarantee the users who sign individual contracts arising from the Collective Agreement that in fulfilling the obligations pertaining to broadcasting copyrighted musical compositions prescribed by such contracts they are indeed settling all obligations towards the authors.
- 2) This Article applies to users-broadcasters who possess a permit from the Communications Regulatory Agency of BiH (RAK) for terrestrial broadcasting of radio or television programs and who adopt a single, annual statement of accounts (balance sheet or a profit or loss statement) regardless of whether the user is a radio, television or radio-television broadcaster or whether the program is rerun via new technologies (streaming, cable etc).

The tariff for the abovementioned user is:

- 3.2% for a radio broadcaster
- 2.4% for a radio-television broadcaster
- 1.6% for a television broadcaster.
- 3) The minimum fee to be paid annually to the Collective organisation by the user referred to in Paragraph (2) of the Article for the use of copyrighted compositions regulated by this Agreement and individual contracts is:
  - 1,800.00 BAM for radio
  - 5,400.00 BAM for radio-television
  - 3.600.00 BAM for television

The tariff and the discount for the abovementioned user is shown in the table below:

## Article 2

The Annex of the Agreement is executed in four identical copies, one copy to be kept by each of the Contracting parties.

### Article 3

The Annex of the Agreement shall be considered concluded on the day of being signed by the Contracting parties and shall become legally binding upon publication in the "Official Gazette BiH".

AMUS shall publish the full text of the Annex of the Collective Agreement in the following edition of the "Official Gazette BiH".

#### Article 4

This Annex is a constituent part of the Collective Agreement and therefore is subject to all the provisions of the Agreement.
